It is the intention of the CBTAH to enhance the public awareness to the benefits of CBT and utilising Hypnosis / Hypnotherapy for it's therapeutic effect.

Qualifications for membership.

Membership is limited to professional hypnotherapists who have completed a CBT or CBH Training Course.

- Applicants must hold a qualification in Hypnotherapy, CBT, CBH, NLP or Psychotherapy and are in practice.
- Applicants must be able to show a commitment to their own ongoing professional development such as attending advanced / master class training courses, and to pledge that they will continue with their ongoing professional development. A minimum of 30 hours credits in any 12 month period are needed to maintain membership.
- Applicants / members must hold an up to date public indemnity / liability insurance for a minimum of two million pounds (£2.m)
- Applicants must supply the name and address of two unrelated people who can give a reference, one of whom must be in full time practice working as a hypnotherapist, or the name of an existing CBTAH member who is willing to support the application.

Successful applicants will receive a certificate and be entitled to use MCBTAH after their name and on advertising. Their details will be published on the CBTAH web site.

All members must adhere to our Code of Ethics, (published on the web site).
